- Chief Harris advised he had a meeting with Superintendent Kratochvil. They are going to close the alleys down and block the streets during the construction. Jeff Schober advised they will take care of that and advise Petersburg.
- Chief Harris advised he met with Axon. He was able to see what Axon's products are. They are the best for cameras. He has an estimate of \$70,315.70 for the body cams and storage. The cost of cameras in cars is \$58,968.00. This is a 5 year contract. After 2.5 years, they provide us with new cameras and docking stations. At the end of the 5 years, you will have newer equipment. The county has the same cameras. Eventually, the state will also have these cameras. Trustee Murphy advised the cost will be about \$2000/mo. We could just have the body cams, however, we would be missing a lot while the officers are in the car. Trustee Murphy believes we should move forward with purchasing the cameras. Trustee Walters believes we should move forward with the body cams. Trustee Skinner thinks we should ask for a loaner car cam to see how those work. Trustee Whitson thinks we should just move forward with the entire project. Trustee Skinner asked about a bundle discount. Chief Harris will ask.

Trustee Walters advised they are buying in bulk and then storing here. Trustee Whitlow advised it is materials they are purchasing for our project.

• Treasurer Wise advised he has been researching ways to get ahold of residents when the power is out. He talked to other municipalities and Scott Day and this is what other municipalities are using and what is recommend. People would sign up for emails or text messages. It could be used for boil orders, power outages, etc. By opting in, it does give the company the right to GPS track you. Onsolve is the name of the company. It would also do weather alerts. The company does have the 911 list. They would allow us to send a 1 time text to everyone in the community to opt in.

 President Clarke advised he had a conversation with Vistra. They own the power plant. They are scheduled to close in 2028. They have an ash pond. The EPA is requesting that they haul away all of the ash out of the ash pond. They would like to close in place. They are looking for a letter to the EPA from the Village of Pawnee, Kincaid and Christian County to approve them to pour a membrane over it to enclose it as opposed to hauling it away. Without our letter, EPA wants them to haul the coal ash out of there. They would like to pour a membrane over it and then put solar panels on top of it. Hauling it away would take 327,000 truck loads for a total of 8.5 years not to mention wear and tear on the roads. President Clarke discussed it with Kincaid and they are waiting to see what we are doing. Christian County is neutral. Consensus was to close in place.
