#### Visitor's Recognition/Comments:

• Brandon and Nichol Goodall appeared before the Board. Andy Lee advised the Board the details surrounding getting them water. He advised we purchase our water from Otter Lake. When we get the water, it is at a set pressure. Otter Lake's lines are in bad shape and therefore, the pressure is lower. They are planning to replace the line in 2024. When the line does get replaced, the pressure will be bumped up. However, we will not be able to run at the increased pressure due to our infrastructure. He also advised we need to take care of our residents first before we can stretch outward. There are about 5 houses or subdivisions that are the same distance or closer. If we service them, we would have to service everyone and our system is just not designed to handle this. He further advised they are in another county. He believes this should be Tovey's decision as they are Tovey's customer. Nicole Goodall said she has found some grants, up to 75%. There are 3 very large grants the township could get access to because of them. Andy Lee stated that regardless, the Village infrastructure could not sustain it. If it was just them, maybe, but everyone else is going to ask and how do we say yes to one person and no to another. Andy Lee provided them with the name of someone from Tovey.

#### Gas and Water Committee Report: Committee Chair, Trustee Whitlow

- Trustee Whitlow advised there were 72 red letters sent out and 4 shut offs.
- Andy Lee advised Petersburg is getting ready to start on Phase 2. They will be breaking ground Wednesday of this week at 10<sup>th</sup> and Lincoln. They believe they can complete the project in 3 months. Trustee Walters asked about getting the fire trucks out. Andy Lee advised there should be no issues with getting multiple trucks out at any given time.
- Discussed the 4<sup>th</sup> and Sherman storm drain issues and moving the gas main. Andy Lee stated it would be easy to move. His biggest concern would be moving it and then it's in the way for another project and has to be moved again. We are still waiting to hear back from our engineer in order to determine what action the Board will take.
- Andy Lee advised the Board every year he holds an Emergency Meeting. This year, it will be December 13<sup>th</sup> at 6pm. It is the first responders meeting that the State requires him to have.
