President Clarke advised that there would be no issues so long as it doesn't block the view of Rt 104. He advised they would like to put it parallel to the building. He is going to be building his own food truck but it will be a while before it's ready. He wants to have the traffic get used to seeing a food truck there, so until he gets his truck complete, he is going to have a variety of food trucks come in. The Board advised the single use permit is \$100 and would cover up to 5 days. He advised Nick Campo is all for it. For the temporary trucks, he is thinking maybe 3-4 times per month. The Board advised that once his truck is ready, it would be \$300 annually for a permit. He is still working out all the details but is thinking his truck would be maybe Friday – Sunday for lunch. Discussed the temporary permit. Trustee Walters advised the intent was the operator pays the \$100 fee with the 5 day window. They would fill out an application and provide their Sangamon County license. He could pay the fee for them, but the permit would be in their name. He'll get dates and we'll discuss it further at the next board meeting.
