- Andy Lee stated they got all the OSHA requirements completed. With that, they are finishing up the project near 55. Otter Lake is also finishing up their side and should be completed within

2weeks. Our water pressure will go from 45/46lbs of pressure to 77lbs of pressure. He is planning to wait until May to fill tower. They'll test the pressures to see what happens. Higher the tower, the more pressure it gets in the home.


- President Clarke discussed the Christmas decorations and storage container. Trustee Guess will check into prices. Decorations will come down once weather permits.
